PONY EVENT AGREEMENT

MINIMUM PARTY SCHEDULE IS 2 HOURS AT THE RATE OF \$125 PER HOUR. This rate is non-negotiable. Rate time begins and is applied once the pony is unloaded at event location (OR) at the onset of our basic equine safety and rules which will be first discussed with attending children and adults as a group before any activities with the horse / pony begins. Maximum time is 4 hours. Our ponies are our pets first and we will not over work them.

Dates will only be confirmed with receipt of deposit. **NON-REFUNDABLE \$100.00 DEPOSIT REQUIRED TO BOOK EVENT DATE.** Deposited can be CASH or Credit Cards via PayPal PAYABLE TO PENNY MIKEMAN. PERSONAL CHECKS ARE NOT ACCEPTED. BALANCE DUE UPON PONY'S ARRIVAL AT YOUR EVENT. Should bad weather occur on your date and we are not able to make your event, you may reschedule and get an extra hour for free. All rescheduling **MUST** be done in writing and within 90 days of your original event date, otherwise we will consider you no longer interested in our services and deposit is forfeited.

BINDING AGREEMENT:

- ✓ As a host we agree to be wholly and entirely responsible for every person or animal at the event regardless of being invited or not, including any 3^d parties not part of this agreement. We release pony and owner, Penny Mikeman of any and all liability. In Texas there is a civil remedies code that reads as follows: **WARNING: UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.**
- ✓ We also agree that we will be responsible for any medical expenses or harm presented to the pony during event.
- ✓ As the host(s) of the above stated event, (I / we) agree to be completely and wholly responsible for the safety and behavior of all children, adults and other pets on our property whether invited or not invited including any 3rd parties not part of this agreement. We fully understand the Texas Equine Liability law as stated above.
- ✓ As hosts it is our responsibility to provide an approved safety helmet for children under the age of 18 years. If we choose to NOT provide a helmet, we accept full responsibility as stated above.

- ✓ As hosts we also agree to NOT have our yard chemically treated within 10 days of our scheduled event.
- ✓ We also agree that we will not have any loose dogs on our property. If a loose dog appears the pony will be stopped until the dog can be removed.
- ✓ We also agree that if our scheduled time is exceeded due to continued rides or photo ops, this balance will also be paid before the pony leaves the event.
- ✓ ONE CHILD AT A TIME MAY ENTER CART WITH PONY'S DRIVER or MOUNT PONY IN SADDLE.
- ✓ Children smaller or younger than 4 who can not effectively hold themselves in the saddle will be escorted by parent, guardian or event hosts at all times while in saddle.
- ✓ We agree that Dream Big Ponies does NOT tie or otherwise strap children into the saddle or cart.
- ✓ Event guests including children will not feed the pony any food items other than that provided by Penny Mikeman.
