2010 PONY PARTY EVENT AGREEMENT

1 hour parties: \$125.00 within 20 miles of our home | \$155 within 21-40 miles | \$190 within 41-60 miles

1.5 hour parties: \$165 within 20 miles of our home | \$195 within 21-40 miles | \$225 within 41-60 miles

This rate is non-negotiable. Rate time begins and is applied at the onset of our basic equine safety and rules which will be first discussed with attending children and adults as a group before any activities with pony begins. NO CHILDREN ALLOWED ON SADDLE OVER 65lbs. PARENTS PLEASE CHECK THIS BEFORE PARTY STARTS, SO THAT NO ONE'S FEELINGS ARE HURT IN FRONT OF OTHER CHILDREN.

Dates will only be confirmed with receipt of deposit. **NON-REFUNDABLE DEPOSIT (\$25 for 1 hr/\$30 for 1.5 hr) REQUIRED TO BOOK EVENT DATE. PERSONAL CHECKS ARE NOT ACCEPTED. THE BALANCE IS DUE BEFORE PONY IS UNLOADED AT EVENT along with this agreement signed by host.** Refunds are offered only due to bad weather occurrences on your date which cause us to be unable to make your event; If you choose to reschedule it must be within 90 days of your original event; Lack of contact WITHIN 90 DAYS for rescheduling will forfeit the deposit. BINDING AGREEMENT:

- As the host(s) of the above stated event, (I / we) agree to be completely and wholly responsible for the safety and behavior of all children, adults and other pets for the duration of pony at event on public or private property whether invited or not invited including any 3rd parties not part of this agreement. We release pony's owner, Penny Mikeman and pony assistants and all heirs of any and all liability. We fully understand the Texas Equine Liability law as stated here: **WARNING: UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.**
- As hosts we also agree to NOT have our yard chemically treated within 10 days of our scheduled event.
- As hosts we also agree to effectively put away our dogs, cats, or other animals that may distract or harm pony.
- We also agree that we will be responsible for any medical expenses or harm presented to the pony during our event.
- We also agree that if our scheduled time is exceeded due to continued rides or photo ops, this balance will also be paid before the pony leaves the event at the rate of \$50 per 30 minute increments.
- ONE CHILD AT A TIME MAY ENTER CART WITH PONY'S DRIVER or MOUNT PONY IN SADDLE.
- CHILDREN younger than 4 years or who are disabled and can not effectively hold themselves in the saddle will be escorted by parent, guardian or event hosts at all times while in saddle.
- Event guests including children will not feed the pony any food items other than that provided by Penny Mikeman.
